DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Located on the northwest side of the intersection of U.S. 50 at Rockwalkin Road, the William Murray House is a two-story frame dwelling of a late nineteenth century construction date.

This two-story plus attic frame house has a three bay front elevation facing south, with a central gable and one story shed roofed screened porch. The gable retains its original imbricated shingles and sunburst brackets, but the rest of the exterior is now covered in asbestos siding. The gable has a small 2/2 sliding sash window and the rest of the windows on the front and side elevations are also 2/2. The porch roof has a small pediment over the central entrance door and the main entrance door has a lentel molding on the horizontal architrave.

A two-story rear ell has a bulkhead on the north side and one-story shed roofed additions on the east and west sides. The house has two central chimneys in the main section and an interior end chimney in the rear ell.

The site consists of the residence and three outbuildings of varying construction dates, from contemporary with the residence to the early 20th century. The exteriors of the outbuildings have been altered and they vary in condition from fair to deteriorated.

Several large trees occupy the area between U.S. 50 and the house and the entire site is surrounded by cultivated fields.

This is a typical late-19th century farmhouse found throughout Maryland with simple decorative details characteristic of the vernacular architecture of the period. Its site along U.S. 50 represents the early settlement pattern of farms along the main route from Cambridge to Salisbury.


