DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Robinson House is a 2.5 story frame house dating from the late 19th century located at the northeast corner of Water and Taylor Streets in Sharptown, Maryland. The entrance is oriented southeast toward Water Street.

The Robinson House is an irregularly planned house with a three-bay gable roofed section fronting on Water Street and a single bay gable roofed elevation facing Taylor Street. The entrance is through a shed-roofed one story porch which wraps around the Water Street facade and part of the Taylor Street elevation. The porch roof breaks into a small gable over the entry. The Taylor Street elevation has a bay window at the first floor. The Water Street gable is shingled in three patterns and has a group of three windows, the center window taller than the flanking openings. The Taylor Street gable has a single window. Most windows in the house are 1/1. The exterior is covered in weatherboards and the roof is of modern material. A single chimney protrudes from the junction of the two gable portions in the center of the house. The porch has turned columns and is partially enclosed by screens in a T-frame extending from the porch eaves and floor. The unenclosed section has a plain balustrade.

STATEMENT OF SIGNIFICANCE

The Robinson House is a typical late 19th century house found in many small Eastern Shore towns. However, it exemplifies many conventions of the period: multiple shingle patterns, bay window, grouped fenestration, turned columns, and an irregular plan. This relative sophistication in comparison with other small town houses reflects Sharptown's prosperity and links to larger urban centers during the period of greatest shipbuilding activity, approximately 1875 to 1920. The shipyard was located at the foot of Taylor Avenue, not far from the Robinson House.


