DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Watson House is a late nineteenth century frame house located on the southwest corner of Railway and Vine Streets, facing west toward Railway St., in Sharptown, Maryland.

The house is a two and a half story gable-roofed structure with a three-bay facade. The north bay is a polygonal bay with overhanging gable at the top story. The gable has patterned shingles and a pointed 2/2 window with a scroll-sawn decorative bargeboard. The gable overhang has scroll-sawn brackets and pendants. The remaining two bays of the facade are spanned by a one-story shed roofed porch with turned columns and perforated brackets.

The exterior was probably originally covered in weatherboards, but is now faced with asbestos siding. The Vine Street elevation was probably two complete bays originally, but the lower floor windows have been removed.


