Situated along Whitehaven's waterfront, the Phillips house, also known as the John W. Wingate house, is a late nineteenth century two-story, gable-front frame dwelling trimmed with modest Victorian sawnwork. A turned post front porch with decorative brackets and drop pendants shelters the side entrance and an adjacent window that lights the parlor. The double-pile main block is extended on each side by two-story bay pavilions that boast modest late nineteenth century decoration as well. A two-story kitchen wing extends to the rear, and it incorporates a two-story side porch.

Construction of this house is estimated to date around 1890 during the ownership of John W. Wingate, who purchased what was known as the "Byrd property" in 1872. John W. Wingate operated a mercantile business on the land in front of the house between "Main Street" and the river. "J. W. Wingate" is listed in the 1877 Lake, Griffing, and Stevenson atlas as a dealer in

Dry goods, Groceries, Hats, Caps, Hardware, Queensware, Glassware, Ready-made clothing, Confectionery, Wines, Whiskies, Brandies and Rum, and all articles usually kept in a first class country store."

John W. Wingate mortgaged his dwelling house and lot in 1889, perhaps in an effort to raise money to build a new house.

John W. Wingate sold the "Byrd Property" four years later to John Dorman, who in turn sold it the following year to William W. Larmore. In

1949 the house and lot were purchased by William J. and Mildred B. Wilson, in whose family the property remains.

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Phillips house, historically identified as the John W. Wingate house, stands at 23832 River Street in Whitehaven, Wicomico County, Maryland. The two-story, two-bay, gable-front frame house faces south with the gable roof oriented on a north/south axis.

Dating to around 1890, the two-story side hall/double-pile plan dwelling is supported on a raised brick foundation, and the structure is sheathed with a combination of plain weatherboards, aluminum siding, and fishscale shingles. The steeply pitched roof is covered with asphalt shingles. Attached to the back of the main block is a two-story service wing.

The south (main) elevation is an asymmetrical two-bay facade with a side entrance and flanking two-over-two sash window hung with louvered shutters. The front door is glazed above the lock rail and it has multiple panels below. The first floor is sheltered by a turned post front porch embellished with decorative sawn corner brackets and drop pendants between posts. A small cross gable is fixed over the entrance with part of the sawn peak decoration surviving. The second floor is lighted by a pair of two-over-two sash windows. Piercing the gable end to light the attic are two small one-over-one sash windows paired next to one another. The peak of the gable end is embellished with modest Victorian sawnwork. A brick chimney rises through the center of the main block.

The east and west sides of the house are dominated by two-story bay pavilions topped by gabled pediments that feature fishscale shingles and decorative drop pendants on the outside corners. Sawn peak decorations embellish each gable end and two-over-two or single-pane sash windows light the first and second floors. Paired one-over-one sash windows mark in gable end pediment.

The north (rear) wall of the main block is largely covered by a two-story kitchen wing that incorporates an engaged two-story porch on the east side. Like the front porch, the side porch is embellished with Victorian eave decoration.

The interior was not seen.

Standing directly east of the kitchen wing is a single-story, gable-roofed outbuilding with a gable-front roof extended over the squarish weatherboard structure. Small bracket supports underpin the cantilevered roof. The extended roof protects a shallow profile four-panel door.

John W. Wingate mortgaged his dwelling house and lot in 1889, perhaps in an effort to raise money to build a new house. (FMS 4/490)

John W. Wingate sold the "Byrd Property" four years later to John Dorman, (JTT 14/165) who in turn sold it the following year to William W. Larmore. (JTT 14/180) In 1949 the house and lot were purchased by William J. and Mildred B. Wilson, in whose family the property remains. (JWTS 309/36)

Due to the relatively well-preserved nature of this house, it deserves a Category B listing, which indentifies it as a house that should be preserved since it is a structure that exhibits good architectural details representing a good example of architectural development and style and supports the overall character of the district.






