Store proprietor William F. Allen and his wife Eleonora resided in this two-story, three-bay frame house when it was new in 1870. Reported to have been financed by his mother, Mary Whittington Allen, the house served as the family's residence through the balance of the nineteenth century. In her will, dated May 10, 1879, she bequeathed "my house and lot where William F. Allen now resides," to her grandchildren, Grace, born in 1875, and Percy, born in 1878. In the 1880 United States census, William F. Allen, aged 49, is listed as a dry goods merchant, with his wife, Eleonora and the two children. William F. Allen remained in the store partnership with his brother, Joseph S. C. Allen, until 1883. Eleonora Allen continued to reside in the house during the early years of the twentieth century. In 1927 the property was sold by the Allen family heirs. During the mid twentieth century the house was moved back from the edge of the road where it was originally built.

The William F. Allen house is located on the east side of Allen Road in the village of Allen, Wicomico County, Maryland. The two-story, three-bay frame dwelling faces west with the gable roof oriented on a north/south axis.

Built in 1870, the two-story, center hall frame house was relocated during the mid twentieth century from its former location closer to the street. Supported by a continuous brick foundation, the exterior of the single-pile dwelling is covered with vinyl siding, and the medium pitched roof is sheathed with asphalt shingles. Attached to the back of the main block is a single story, one-room plan kitchen wing.

The west (main) facade is a symmetrical three-bay elevation with a center entrance and flanking six-over-six sash windows. The replacement front door is framed by a four-light transom and four-light sidelights. The entrance is sheltered by a single-bay hip roofed stoop with Tuscan columns. The second floor is lighted by three evenly spaced six-over-six sash windows. Finishing the base of the roof is a boxed cornice.

The south gable end is defined by an exterior common bond brick chimney distinguished by corbelled shoulders. Six-over-six sash windows light the first and second floors to each side. Small four-pane windows pierce the gable end, which is finished flush and trimmed with a plain bargeboard.

The north gable end is treated in a similar fashion with an exterior common bond brick chimney flanked by six-over-six sash windows on each floor. Small four-pane windows light the attic.

The east (rear) wall of the front block is partially covered by a single story, one-room plan kitchen wing.

The interior was not seen.

Standing south of the house is a single-story frame garage.



Store proprietor William F. Allen and his wife Eleonora resided in this two-story, three-bay frame house when it was new in 1870. Reported to have been financed by his mother, Mary Whittington Allen, the house served as the family's residence through the balance of the nineteenth century. In her will, dated May 10, 1879, she bequeathed "my house and lot where William F. Allen now resides," to her grandchildren, Grace, born in 1875, and Percy, born in 1878. (Wicomico County Register of Wills, ELW 1/45) In the 1880 United States census, William F. Allen, aged 49, is listed as a dry goods merchant, with his wife, Eleonora and the two children. William F. Allen remained in the store partnership with his brother, Joseph S. C. Allen, until 1883. Eleonora Allen continued to reside in the house during the early years of the twentieth century. In 1927 the property was sold by the Allen family heirs. (Wicomico County Land Record, JCK 148/285, Shivers, p. 229) During the mid twentieth century the house was moved back from the edge of the road where it was originally built.

The William F. Allen house falls into *Category C*, which identifies properties where alterations should be considered carefully since the structure stands near a house in the A or B categories and since it contributes to the historic character of the village.


