The Pollitt-Kolb house, historically identified as “Cherry Hill farm,” is located on Pollitt Road on the northern side of the village of Allen. Estimated to date to the mid-nineteenth century (c. 1850-1870), the two-story, one-bay wide main block is extended to the east and south by single story or story-and-a-half one-room plan wings. Exterior architectural finishes include narrow corner pilasters and boxed cornices. Sheathed with plain weatherboard siding, the house is lighted principally by six-over-six sash windows.

Chain of title research for this property traces the history of this property back to the mid-nineteenth century ownership by Charles B. Lore, a resident of the City of Wilmington, Delaware, who acquired the house and land in December 1869 from Richard S. and Elizabeth Bounds. Charles Lore surfaces in the historic record as the assistant minister for the Asbury M. E. Church in 1858. He is designated as owning this property on the District No. 7 map of the Lake, Griffing, and Stevenson atlas (1877) as well as several other houses and parcels in Somerset County along or near the path of the Eastern Shore railroad. The local station was named, “Loretto,” after Charles B. Lore. He maintained ownership of the Allen house throughout the balance of the nineteenth century, ultimately selling it to Alpheus Porter for \$800 in July 1900. Alpheus S. and Letitia E. Porter held title to the property for sixteen years, and sold it to Jesse M. and Agnes M. Pollitt in July 1953. Three years later the Pollitts purchased the old Huffington house and sold the Lore property to David W. and Mary Lee Kolb.

The property historically known as Cherry Hill farm is located at 3535 Pollitt Road in the village of Allen, Wicomico County, Maryland. The two-story frame house faces west with the principal gable roof oriented on a north/south axis.

Estimated to date to the second quarter of the nineteenth century (c. 1850), the house is comprised of a two-story main block extended to the south by a story-and-a-half wing and the to rear by a single-story kitchen. The structure is supported by a low brick pier foundation, and the exterior is clad with plain weatherboards. The steeply pitched roof slopes are covered with asphalt shingles. The nineteenth century structure forms an ell shape, and a mid twentieth century single story flat-roofed addition has been added within the inside corner of the structure.

The main (west) facade is an asymmetrical elevation with a two-story, one-bay, one room plan main block extended to the south by a story-and-a-half, two-bay, one-room plan wing. The two-story section has a later bay window on the first floor and a six-over-six sash window on the second floor. The corners of the two-story section are trimmed with plain pilasters, and the cornices are boxed. A single flue brick chimney rises through the south gable end. The west wall of the story-and-a-half wing is marked by a door and window on the first floor and a small two-over-two sash on the second floor. The base of the roof is finished with a boxed cornice.

The south side of the story-and-a-half wing is defined by a single six-over-six sash window on each floor, and a small louvered vent marks the upper gable. The edge of the roof is flush and trimmed with a plain bargeboard.

Attached to the back of the two-story main block is a two-story single-bay extension covered by a gable roof turned on a perpendicular axis to the front section. Extending from the east wall of this two-story rear section is a single-story kitchen wing, which has a shed dormer lighting the loft. The mid-twentieth century in-fill covers the south side of the kitchen wing as well as the east wall of the front block.

The interior was not seen.

(Wicomico County Land Record, JTT 28/206) Alpheus S. and Letitia E. Porter held title to the property for sixteen years, and sold it to Jesse M. and Agnes M. Pollitt in July 1953.(JWTS 351/28) Three years later the Pollitts purchased the old Huffington house and sold the Lore property to David W. and Mary Lee Kolb. (Wicomico County Land Record, 405/50)

This house deserves listing in *Category B*, signifying that it should be preserved since it is a structure that exhibits good architectural details and maintains an intact state of preservation. The house supports the historic character of the village of Allen.






