Commonly referred to as the Nichols house, this two-story rectangular frame dwelling is a late nineteenth century structure that differs significantly from the more common late Victorian dwellings that define the village of Allen. In contrast to the two-and-a-half story, three-bay houses that populate the village, this house has a narrow and vertical two-bay principal elevation designed with a side entrance and a low pitched hip roof in stead of the more common gable roof. A turned post porch, common for the late nineteenth century, features sawn corner brackets.

Construction of the house is estimated to date to the late decades of the nineteenth century, probably around 1880-1890. The property during that time was held by a Theodore W. Pusey, who is recorded in the land records as operating a store on the lot. The house, store, and lot entered into a trusteeship under the care of Robert F. Brattan, who sold the property in June 1890 to Andrew Jackson Huffington. A. J. Huffington and his wife, Elizabeth, held onto the property for 10 years, and sold it to Ashland F. Malone in May

In 1931, sisters Lulu and Ruth Nichols purchased the house and lot, and the property remained in Nichols family hands until 1992. Lulu Nichols was the postmaster in Allen between 1946 and 1967.

The Nichols house stands on the south side of Post Office Road in the village of Allen, Wicomico County, Maryland. The two-story, two-bay frame house faces northwest.

Dating to around 1880, the two-story, side hall plan frame house is supported by an infilled brick pier foundation, and the exterior is clad with asbestos shingles. The low pitched hip roof is covered with asphalt shingles. Attached to the back of the double-pile main block is a single-story kitchen wing.

The northwest (main) elevation is a two-bay facade with a partially glazed door side entrance and two-over-two sash window marking the first floor. A turned post hip roof porch shelters the first floor, and sawn eave brackets mark the upper corners. A pair of two-over-two sash windows light the second floor. The windows are framed by plain surrounds. Finishing the base of the roof is a boxed cornice trimmed with bed and crown moldings.

The southwest side elevation is two bays across with a pair of two-over-two sash windows lighting the first and second floors. Rising through the roof is a centrally located single flue brick chimney. The northeast side elevation, on the other hand, has a single two-over-two sash window in the right bay and a small bay window to the left. The second floor is lighted by two-over-two sash windows.

The rear wall of the main block is partially covered by the single-story, one-room plan kitchen wing, which has a single-flue brick stove chimney rising through the gable end. A shed addition extends the kitchen wing to the rear.

The interior was not seen.

In 1931, sisters Lulu and Ruth Nichols purchased the house and lot, and the property remained in Nichols family hands until 1992. (Wicomico County Land Record, 1298/411) Lulu Nichols was the postmaster in Allen between 1946 and 1967.

This house falls into *Category C*, which identifies properties where alterations should be considered carefully since it adjoins a property listed in the A or B group. The house retains its general late nineteenth century integrity and contributes to the historic nature of the village.


