1897

A short newspaper item printed in the *Salisbury Advertiser* on August 14, 1897 announced the near completion of this prominent two-and-a-half story Queen Anne residence at 501 North Division Street. The paper stated, "Mr. F. A. Grier's new residence on the corner of Division and Isabella streets is being pushed towards completion rapidly. The location of the lot is one of the most prominent in Salisbury." Clearly taking advantage of the corner location is the Frederick Grier house, which has its principal entrance incorporated in a three-story tower oriented to the corner of the intersection. The corner design is further strengthened by the Tuscan columned front porch, which has a gabled facade centered on the double entrance doors. The porch stretches to each side to meet two-and-a-half story pavilions that rise on each principal elevation. Similar to other elaborate Queen Anne residences in Newtown, the exterior is enriched with a wide variety of architectural detail that includes eyebrow windows on the main roof, a decorative metal railing on the south side porch roof as well as the contrasting fishscale and weatherboard exterior sheathing.

The Frederick A. Grier, Sr. house stands at 501 North Division Street on the northeast corner of its intersection with East Isabella Street in the heart of the Newtown Historic District in Salisbury, Wicomico County, Maryland. The two-and-a-half story, asymmetrical Queen Anne style frame house faces southwest.

Built in 1897, this large two-and-a-half story Queen Anne dwelling was erected with its principal entrance facing the corner intersection. Elevated on a raised brick foundation with an excavated cellar, the weatherboard frame dwelling is covered by a steeply pitched hip roof of patterned slate. The eaves are extended eaves with exposed rafter ends. Attached to the main block are two-and-a-half story pavilions that extend the house forward, and to the rear is a two-and-a-half story service wing.

The southwest (main) entrance elevation is incorporated in the corner of the main block. A double door entrance is topped by a three-light transom, and the trim around the doorway is molded. The front door, as well as adjacent single-pane sash windows, are sheltered by a Tuscan columned porch. Slender paired columns rise from brick plinths, and a dentil molding decorates porch cornice. Stretching between the porch plinths is a rectangular baluster handrail. The corner of the porch is highlighted by a small pediment sheathed with fishscale shingles. Fixed on the east (right) side of the porch is a small metal fenced balcony accessed to a second floor window. Rising atop the porch roof and directly above the entrance is a two-story conical roofed tower. The level above the porch is distinguished by slender Tuscan columns which flank narrow single-pane sash windows. The third floor or next level is sheathed with fishscale shingles, and pierced by sixteen-over-one sash windows. The conical tower roof is covered with patterned slate and decorated with small brackets under its cornice. A metal weathervane rises from the point of the tower. Marking the roof to each side of the tower are narrow eyebrow windows, and the roof peak is finished with a decorative metal cresting. Tall brick chimneys rise through the roof and are finished with corbeled caps.

Projecting from the south side of the main pyramidal roofed block is a two-and-a-half story pentagonal pavilion with single-pane sash windows lighting the first and second floors. Rectangular two-pane windows pierce the brick foundation. The five-sided pavilion walls rise to a gable-front roof sheathed with fishscale shingles and pierced by a Palladian tripartite window. Long cornice blocks define the underside of the gable roof.

Extending from the west side of the main block is two-and-a-half story pavilion with squared front edges and a single-story bay extension on the first floor. The second floor is pierced by paired windows, and the third floor is illuminated with small paired windows with multi-pane sash windows. The gable end around the attic windows is covered with fishscale shingles. Finishing the edge of the roof is an extended eave with exposed rafter ends.

On account of its elaborate architectural detailing and well preserved condition, the Frederick A. Grier, Sr. house is listed in *Category A*, which identifies buildings that must be preserved.

Extending from the back of the main block is a two-and-a-half story, two-bay by two-bay kitchen wing that is covered by a steeply pitched jerkinhead roof. Attached to the east side of the kitchen wing is a two-story shed roofed addition, which is extended farther east by a single story shed roofed section. A shed roof porch supported by Tuscan columns stretches across the west side of the kitchen wing and shelters a side entrance and single-pane sash window. The second floor is lighted by single-pane sash as well, and a shed roofed dormer marks the roof. The dormer is fitted with three six-pane windows. Piercing the roofline is a narrow brick stack finished with a corbeled cap. The rear wall of the kitchen wing is marked by pairs of windows on each floor. A gable roofed cellar entrance extends from the back wall between the two first floor windows.


