While the original owner and builder of this house is uncertain, the two-story, two-part dwelling dates from the late years of the nineteenth century. The tall one-room plan main block is extended to the north with story-and-a-half one-room plan wing features the same exterior features included extended eaves with exposed rafter ends, gable end stove flues, and five-panel doors with ogee inset moldings. Lillian Cooper's association with the property began in 1931, when she and her husband Frederick C. Cooper purchased the 3/4-acre parcel.

The Lillian Cooper house is located near the intersection of Wetipquin and Royal Oak roads in the community of Wetipquin, Wicomico County, Maryland. The two-story, two-part frame house faces east with the gable roof oriented on a north/south axis.

Estimated to date around 1880, the two-story, two-bay, one-room plan frame house is supported by a brick pier foundation and it is sheathed with plain weatherboards. The steeply pitched gable roof is covered with asphalt shingles. Attached to the north gable end of the main house is a story-and-a-half one room plan wing.

The east (front) facade of the two-bay main block is defined by a five-panel door in the right bay flanked by a two-over-two sash window. The front door has ogee inset moldings that frame each panel. The second floor is lighted by a single, centrally positioned, two-over-two sash window. Extended eaves with exposed rafter ends finish the edge of the steeply pitched gable roof.

The south gable end is a blind weatherboard wall with an interior end brick stove chimney piercing the roofline. The edge of the roof is extended with the soffit open.

The rear wall is marked by single two-over-two sash windows on the first and second floors.

The north gable end of the main block is covered by the story-and-a-half frame wing, which appears to date from the same period as the main house. The east elevation is a two-bay facade with a five-panel door located in the left bay, and it is flanked by a two-over-two sash window. The door panels have the same ogee inset molding as the door in the main block. The knee wall is pierced by a two-pane window. The edge of the roof is finished in the same manner as the main block with extended eaves and exposed rafter ends.

Like the south gable end, the north end is a blind weatherboard wall with an interior end brick chimney rising through the roof.

The interior was not seen.

The house qualifies for listing in *Category B*, which identifies buildings that should be preserved for their architectural and/or historical merit. This two-part dwelling represents the type of house erected for lower class white or black families that occupied small acre or half-acre parcels.


