The property known as Rolandhurst is located on the north side of Quantico Creek east of the village of Quantico. Improved by a two-story center hall frame house erected around 1870 and remodeled during the early twentieth century, the property was made famous locally for the extensive nursery developed by Roland J. Bailey between his purchase of the farm in 1913 and his death in the 1950s. The farmhouse extant on the property followed the common two-and-a-half story, cross-gabled form with center hall and a single room to each side. Attached to the back of the house was a two-story dining room/kitchen wing that gave a tee shape to the entire house. Construction of the Civil War era dwelling is attributed to William or Thomas H. Giles, who held title to the land during the third quarter of the nineteenth century. Following Roland J. Bailey's purchase of what was known as the "Hopkin's Place," the house was reworked with Colonial Revival details including a colossal columned portico that replaced the simple cross-gabled front. Square columns topped by Corinthian capitals rise to a pediment embellished with a classical relief decoration within the pediment.

Borrowing from some commercial literature explaining the nursery stock during the 1930s and 1940s, Roland J. Bailey offered:

Trees, Evergreens, Shrubs, Vines, and Perennials, Landscape Material for Ornamental Planting, Specialties: Hybrid Lilac, Azalea Mollis, and Pontica,

Hardy Japanese Evergreen Azaleas, red, pink, and white; Japanese Maples and Weeping Flowering Cherries, Chinese Magnolias, white, pink and purple varieties, Koster's Blue Spruce, grafted; Hybrid Rhododendron and Red Flowering Dogwood, Hick's Yew and Meyers Juniper, the New Red Leaved Barberry and Viburnum Carlesi (Korean Snowball)

Following Bailey family sale of the property in 1960, the nursery was handled by a number of firms, although by the mid 1970s the house had fallen into serious disrepair. Russell A. and Ann G. Jones purchased the house and 4.95 acres in 1978 and restored the house.

Rolandhurst is located on the south side of Quantico Road (MD 347) northeast of Quantico, Wicomico County, Maryland. The two-story, three-bay, center hall frame house faces northwest with the gable roof oriented on a northeast/southwest axis.

Estimated to date around 1870 and remodeled around 1910-20, the two-story, three-bay, single-pile frame house is supported on an infilled brick pier foundation that is now painted. The exterior is clad with vinyl siding, and the medium pitched roof is covered with asphalt shingles. Attached to the back of the main block is a two-story, dining room/kitchen wing that gives the entire structure a tee shape. Joining the house on the lot is a single story gable roofed outbuilding and a single story hip roofed brick garage.

The northwest (main) facade is a three-bay elevation with a center entrance and flanking single-pane sash windows. The replacement front door is framed by sidelights and a transom. The adjacent windows have a molded lintel. The center bay is sheltered by a colossal columned portico that rises two full stories and is supported by triple Corinthian columns. The portico roof has a pediment front embellished with a classical wreath and swag design. Extending to each side of the center portico is a single-story shed roofed porch that is supported by triple and paired sets of short Tuscan columns that rest on brick plinths. The porch extends around to the northeast side of the house incorporating a porte cochere. Piercing the second floor of the house is a center doorway that provides access to the second floor porch incorporated within the portico. Single-pane sash windows are located to each side. Rising through the roof is a single brick chimney stack.

The southwest gable is defined by a single one-over-one sash window on the first and second floors, and each window has a molded lintel. The attic is lighted by rectangular two-pane windows that also feature molded lintels. The end to the roof is finished with an extended eave featuring short returns at the base.

The northeast gable end is sheltered by the single-story porch and porte cochere. A side entrance with an oval glass doorway pierces the end wall, and a single one-over-one sash window lights the second floor. The upper gable end is pierced by a pair of two-pane windows, and the eave is extended with returns at the base of the roof.

Attached to the back of the main block is a two-story, three-bay dining room/kitchen wing that is served by a center brick chimney stack. A combination of two-over-two and single-pane sash light the first and second floors. An open Tuscan columned porch shelters the northeast side and the porch on the southwest side has been enclosed.

The interior retains a mixture of third quarter of the nineteenth century and early twentieth century features. Surviving in the center hall is a turned baluster stair anchored by a heavily turned newel post. The stringer is embellished with a scroll decoration.




