A polished granite datestone set in the foundation of this African-American church located south of Quantico documents the construction of this large frame building in 1928 after a fire the year before destroyed the structure erected in 1884. Reverend I. D. Pitts was the pastor at the time of the rebuilding. Supported on a high, rusticated concrete block foundation, the gable-front frame church is defined on each side by rows of rectangular colored glass windows. Small lateral wings on the back of the structure give the building an unusual design in comparison to other black churches in Wicomico County.

While the cornerstone documents the construction of a church in 1884, the Quantico congregation traces its history to the close of the Civil War. On June 24, 1865, the trustees of the Methodist Episcopal Church in Quantico, William Giles, George Moore, Thomas B. Moore, and Nelson Messick conveyed to the "Trustees for the Methodist Episcopal Church for Colored Persons" a one-acre parcel of land known as "Sallop." Serving on the board of trustees at the time were John Henry, Henry Hayman, Robert Ballard, Henry Parker and Abe Spence.

The Mount Zion United Methodist Church stands on the northeast corner of Quantico Road and Giles Lane with the modern address of 6087 Quantico Road, south of the village of Quantico, Wicomico County, Maryland. The single-story frame church faces west with the gable roof oriented on an east/west axis.

Built in 1928, the single-story frame church is supported on a raised, rusticated concrete block foundation, and the exterior is uniformly sheathed with aluminum siding. The steeply pitched gable roof is covered with asphalt shingles. Located behind the church is a nineteenth and twentieth century cemetery.

The west (main) facade is an asymmetrical elevation with the entrance fixed in the southwest corner. A double door opening filled with replacement doors is topped by a round arched, colored glass transom. The adjacent gable front wall is pierced by a center paired, colored glass window which is flanked by single colored glass windows. Fixed in the upper gable is a round arched louvered vent. The edge to the roof is finished with an extended eave and an open soffit. The corner entrance is topped by a truncated bell tower. Fixed in the northwest corner of the concrete block foundation is a cornerstone inscribed, "Built in 1884, Burned in 1927, Rebuilt in 1928, Rev. I. D. Pitts, Pastor."

The north and south side elevations are defined by a series of six colored glass windows. The edge to the gable roof is finished with an extended eave and exposed rafter feet. Rising through the side is an interior brick stove chimney. Attached to the northeast and southeast corners are small single story one-room wings that give the church a tee shape. Colored glass windows pierce the sides of each wing.

The east wall (back) of the church is marked by a series of colored glass windows with a paired set in the center and single windows to each side. The gable end is finished with an extended eave and exposed rafter ends.

The church is joined by a nineteenth and twentieth century cemetery.

The interior was not seen.




