Standing on the northwest corner of Main and Branch streets is a two-story, three-bay frame house that is estimated to be one of a group of second quarter of the nineteenth century dwellings that remain in Mardela Springs. The center hall/single-pile frame house extends to the rear with a two-story, two-room plan service wing. Characteristic of antebellum houses is the eight-panel front door, the flush gable ends, and the Greek Revival woodwork that remains inside. Also common to the mid nineteenth century is the exterior, common bond brick chimney that has corbeled shoulders and a corbeled cap. A gable roofed smokehouse stands behind the house and it retains a few pieces of beaded weatherboards on the north wall. On the west side of the house is a gable roofed well house that is enclosed with weatherboards on the north and west sides and lattice on the other two walls.

The tripartite name attached to his house recognizes the three families largely associated with its ownership. Identified as part of "Ill Neighborhood," the lot was in a larger parcel conveyed from Joshua Brattan to Anthony Brattan on March 3, 1838. The Greek Revival profiles of the woodwork in the hall and parlor--including widely fluted surrounds and plain corner blocks as well as a post and lintel parlor mantel--point to a construction date around that time. Joseph Brattan held title to the same land between 1840 and 1852 and he may have financed construction of the house. The next principal owner of this Main Street property was Thomas B. Taylor, who operated the

store next door for several decades. This house, as well as the dwelling immediately west, are designated on the 1877 Barren Creek Springs map under the ownership of T. B. Taylor. At the time Taylor's estate settlement in 1902 this house was advertised with the balance of his land holdings. A short description of this property was included in the *Salisbury Advertiser*, and it stated the following as part two dozen parcels being offered for sale:

*A house and lot in Mardela Springs where W. H. Beach lives fronting on Main Street of said town, and improved by a two story front building 34 x 18 with porches on front, two story back building, 30 x 18, with side porches, four rooms and hallway between, 5 rooms above, all in good condition; outbuildings, smoke house wood house, barn and stable*

Clearly Thomas B. Taylor rented this house, and it was sold shortly afterwards to Stephen A. Calloway. Ten years later, in July 1913, the house and lot were sold to Margaret E. Truitt, in whose family the property remains to this day.

The Brattan-Taylor-Truitt house stands at 201 Main Street in Mardela Springs, Wicomico County, Maryland. The two-story, three-bay frame house faces south with the roof oriented on an east/west axis.

Built around 1840, the two-story, center hall plan frame dwelling is supported by a low brick pier foundation, and the exterior is sheathed with plain weatherboard siding. The steeply pitched gable roof is covered with asphalt shingles. Extending to the rear is a two-story, two-room plan service wing. A combination smokehouse/wood house is located on the north side of the house, and a pump house stands to the west. The house is historically associated with the Brattan-Taylor store (WI-136), located immediately to the east.

The south (main) elevation is a symmetrical three-bay elevation with a center entrance and flanking six-over-one sash windows. An eight-panel front door is distinguished by narrow Greek panel moldings, and the door is topped by a six-pane transom. Sheltering the front door as well as the adjacent windows is a flat-roofed porch supported by chamfered posts. The roof is accented with widely spaced brackets. The second floor is lighted by three six-over-one sash windows. Trimming the base of the roof is a boxed cornice.

The west gable end is dominated by an exterior brick chimney laid in eleven-course common bond with corbeled shoulders. Six-over-one sash windows light the first and second floors and small four-pane windows pierce the gable end. The edge of the roof is finished with a molded bargeboard. The east end features a rebuilt exterior brick chimney.

The north (rear) wall of the main block is partially covered by a two-story service wing. A shed roofed porch extends from the east side, and a small gable roofed pantry is attached to the west side. The first and second floors feature six-over-six sash windows. An interior brick chimney rises through the middle of the service wing. Like the main block the rear gable end is finished with a molded bargeboard.

The interior of the main block follows a center hall, single-pile plan. A turned baluster stair dating from the late nineteenth century features boldly turned newel posts and a series of turned balusters that support a molded handrail. The eight-panel front door is framed by a fluted surround with corner blocks. A four-panel door framed by a fluted surround and plain blocks opens into the parlor on the west side of the hall. The parlor is a plainly finished room with a mid nineteenth century mantel framing the fireplace. Plain pilasters and a plain frieze board support a thick board shelf.

The room on the east side of the hall features a neo-Federal mantel fixed against the end wall.

The service wing contains the dining room and kitchen. Under renovation at the time of survey, the dining room was originally fitted with a Greek Revival mantel that had been stored in the smokehouse. After several layers of wallpaper were removed the former position of the mantel was evident in the remaining plaster. The mantel will be returned to its original position.

Due to the second quarter of the nineteenth century date and the well preserved condition of the house, it deserves listing in *Category A*, which identifies buildings that must be preserved due to their architectural and/or historical significance.

The kitchen features an enclosed rear staircase behind a narrow beaded board partition and door with a small closet located below. A short handrail has a chamfered newel post and rectangular balusters. The room is finished with a beaded board wainscoting. Shallow profile four-panel doors open into the adjacent spaces.

The second floor of the main block is defined by a center hall with bedrooms to each side. An enclosed staircase featuring a two-panel door is fixed in the southeast corner of the hall. Four-panel doors open into the adjacent bedrooms. The west bedroom features a plain post and lintel Greek Revival mantel.

The attic is unfinished and had a common rafter roof system with a mortise-and-tenon joint at the peak of each rafter pair. Mature cut nails were used in the framing of the gable ends.

Standing behind the house is a gable roofed smokehouse with an attached shed-roofed wood house. Supported on a brick pier foundation, the exterior is sheathed largely with plain weatherboard siding. A single beaded weatherboard survives on the north side of the smokehouse under the rear cornice. The gable roof is sheathed with wood shingles, and boxed cornice stretch across the front and back. The gable ends are finished with a plain bargeboard. Piercing the south wall is a board door. The interior is blackened from years of smoking meat. Attached to the west gable end is a shed roofed wood house.

The well house stands on the west side of the house. The gable roofed structure has two sides, the east and south, enclosed with diagonal lattice, while the north and west walls are sheathed with plain weatherboards. A six-over-six sash window pierces the north wall.


