The Mardela Springs branch of Peninsula Bank is housed in a single story temple- or gable-front brick structure located at the corner of Main and Church streets. Erected in 1919 as the Farmers Bank of Mardela Springs, the temple form building features corner brick pilasters and pressed brick walls with fine mortar joints. The front of the bank building features a boxed cornice that encloses the triangular gable end known as the tympanum. Fixed in the center of the tympanum is a concrete plaque bearing the 1919 construction date. The original entrance is sheltered by a gable-front brick vestibule addition, and east of the vestibule is a double window spanned by a jack arch. A concrete keystone is centered within the arch. During the mid twentieth century the bank was enlarged with a lateral side addition that incorporates a porte cochere drive-through teller window.

The construction of the former Farmers Bank followed the purchase of this corner lot from James E. and Lizzie A. Bacon in January 1919. In exchange for \$200, the Bacons transferred the property to the directors of the bank, which at the time included: Robert G. Robertson, John P. Wright, George P. Waller, James T. Waller, Benjamin F. English, Isaac S. Bennett, Thomas E. Taylor Samuel J. Phillips, John F. Hatton, Joseph H. Lowe, and James E. Bacon himself.

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

Located at 314 Main Street in the town of Mardela Springs, Wicomico County, Peninsula Bank is a single-story ell-shaped brick structure that faces north with the gable roof oriented on a north/south axis.

Built in 1919, the single-story brick structure is located on the southeast corner of the intersection of Main and Church streets. Erected in pressed brick with narrow mortar joints, the original bank building followed a temple or gable-front design which was expanded during the mid-to-late twentieth century with a gable-front entrance vestibule and a lateral single-story wing that extended the early twentieth century building to the east. The addition includes a porte-cochere that incorporates a drive-through teller. The medium pitched roofs are covered with asphalt shingles.

The north (main) elevation is a two-bay facade with a side double-door entrance sheltered by a single-story vestibule addition designed in imitation of the original temple form. Piercing the front wall of the bank on the east side of the entrance vestibule is a double window opening spanned by a jack arch featuring a concrete keystone. The outside corners of the bank building are defined by projecting brick pilasters that rise to a classical entablature. The gable front is highlighted by the triangular pediment. Fixed in the center of the tympanum is a concrete datestone inscribed, "1919."

The Church Street elevation is a three-bay facade defined by large single-pane sash windows. The window openings are spanned by brick jack arches accented with concrete keystones. The foundation is pierced by two rectangular openings with vertical metal bars. The outside corners of the west wall are defined by projecting brick pilasters that rise to a boxed cornice trimmed with bed and crown moldings.

The south (rear) wall is a two-bay facade with two unequal sized window openings. Each window opening is filled with a single-pane sash and accented with a jack arch and keystone. The gable end of the bank is defined by a triangular pediment.

The east side elevation is covered largely by the lateral mid-to-late twentieth century brick addition designed to mimic the early twentieth-century details of the original building. Projecting brick pilasters trim the corners and the window openings are accented with jack arches and keystones.

The interior was not seen.






