The two-story, five-bay frame dwelling that stands at 316 Main Street incorporates a mid nineteenth-century frame structure identified as one of the older houses to remain standing along this principal avenue in the center of Sharptown. The southern three bays of the of the structure comprise the original dwelling that probably dates around the time the lot was transferred to Mary E. Lynch in August 1857. A native of Sussex County, Delaware, Mary E. Lynch paid Jonathan and Matilda Riggin \$40 for 102.6 square perches of what was known as “Robertson’s Delight.” The transfer price indicates the lot would have been unimproved. When the Lake, Griffing, and Stevenson atlas was published in 1877 the map makers indicated that “Mrs. Lynch” resided at this address.

The side hall/parlor house was served by a corbeled base brick chimney stack, which appears on many mid nineteenth-century dwellings in northern Wicomico The two-story, five-bay frame dwelling that stands at 316 Main Street incorporates a mid nineteenth-century frame structure identified as one of the older houses to remain standing along this principal avenue in the center of Sharptown. The southern three fifths County. Additions to the original house extend to the west and north.

Mary E. Lynch held title to the house and lot until her death in February 1905. She died intestate and the property passed to her three grandchildren, Polly A. Culver, Elizabeth E. Culver, and Samuel N. Culver. Mary Lynch’s heirs sold the house and lot to Thomas Covington in 1908.

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

Historically identified as the Mary E. Lynch house, the two-story, five-bay frame dwellings is located at 316 Main Street in the center of Sharptown, Wicomico County, Maryland. The two-story house faces northeast with the gable roof oriented on a northwest/southeast axis.

Estimated to date around 1850-60, the two-story, five-bay frame house is supported on an infilled brick pier foundation, and the exterior is clad with asbestos shingles. The medium pitched gable roof is covered with asphalt shingles. Attached to the rear wall is a two-story, two-bay addition as well as a shed roofed section that fills the rear corner.

The main block was clearly erected in two stages, beginning with a side hall/parlor house that is defined by the three southern bays. A partially glazed front door is sheltered by a gable roofed stoop. There is an indication in the appearance of the roof where the original house meets the later addition between the third and fourth bays. Located to the left of the entrance are two window openings missing their sash. The owners are in the process of replacing the windows. The second floor windows have been replaced. The two northern bays on each floor are filled with two-over-two sash windows. The base of the roof is finished with a boxed cornice trimmed with a crown molding.

The south gable end is dominated by an exterior, corbeled brick chimney base with a single flue stack. Piercing the upper gable end are two four-pane windows. The end of the roof is finished with an extended eave with short returns at the base.

The north gable end features an exterior brick chimney as well, and it has a corbeled brick base and a single flue stack that pierces the extended eave. The attic is lighted by small four-pane windows.

Attached to the west (rear) wall is a two-story, two-bay gable roofed service wing as well as a shed roofed addition.

The interior was not seen.

Due to its age the Mary E. Lynch house qualifies for listing in *Category B*, which identifies buildings of moderate architectural and historical significance.






