Located on School Street in the village of Mardela Springs is a late nineteenth century frame church erected in the Gothic Revival style. Historically known as St. Paul's M. E. Church, the single-story frame structure is distinguished by a three-story entrance and bell tower topped by a crenelated parapet wall. The single-story gable roofed church is defined by long lancet windows with pointed arches and remnants of colored glass. The pointed arch double-door entrance features a pointed arch transom.

The parcel of land on which this church is located was sold by William C. Marsters to the trustees of "Covington's M. E. Chapel" for \$75 in 1886. Serving on the board at the time were William J. Graham, James Horseman, Isaac E. Mills, James A. Venables, Mathias Bailey, and Marcellus Wilson. The deed of transfer, which included 3/8 of an acre, stipulated that the "said premises shall be used, kept and maintained as a place of Divine Worship." According to E. C. Hallman's account published in *The Garden of Methodism* the Gothic Revival church, erected in 1890, was due largely to the work of Reverend J. W. Gray. The congregation altered its name to St. Paul's M. E. Church around the time of construction.

Formerly the St. Paul's Methodist Episcopal Church, the single-story Gothic Revival frame church now used as a warehouse for BowMar Millwork Corporation stands at 107 School Street in the southern residential district of Mardela Springs, Wicomico County, Maryland. The single-story frame church faces south with the principal gable roof oriented on a north/south axis. A congregation has not used this building for more than thirty years. The building is falling into a serious state of disrepair.

Built in 1890, the single-story rectangular frame building is supported on concrete block piers, and the exterior is clad with a combination of plain weatherboard siding on the main body of the building along with a decorative band of vertical sawtooth-edged boards under the eave. The steeply pitched roof is covered with asphalt shingles. Centered on the south gable end is a three-story entrance and bell tower.

The south (main) elevation is a symmetrical facade with the entrance and bell tower dominating the three-bay wall. The first floor of the tower is pierced by a double leaf paneled doors and topped by pointed arch Gothic transom. At the second floor level the tower tapers slightly and the mid section is pierced by a round window that retains portions of colored glass panes. The third floor of the tower is pierced by round arched louvered openings, and the top of the tower is finished with a crenelated parapet. Flanking the tower are pointed arch colored glass windows that retain portions of colored glass. The corners of the church are trimmed with pilasters that rise to an enclosed cornice finished with short returns at the base of the roof.

The east and west sides of the church are marked by a series of three evenly spaced lancet windows with pointed arches and remnants of colored glass. A single flue brick stove chimney rises through the roof.

Attached to the back of the building is a single-story apse covered by a shed roof. The north wall of the apse is obscured by the main Bowmar Millwork office building, which abuts the structure.

The interior has been stripped of its original church fittings. The vestibule in the tower is finished inside with diagonal beaded boards.

Although distinctive with its late nineteenth century architectural details, the building has fallen into disrepair. Despite its condition it deserves listing in *Category B*, which identifies buildings that should be preserved due to their architectural and historical interest.


