Dating to the early twentieth century, the single-story gable-roofed building has a corner, double-door entrance as well as an interior partially sheathed with narrow, tongue-and-groove beaded boards.

The corner lot was held by Mary F. Toadvine and her daughter Annie E. Toadvine during the late nineteenth and early twentieth centuries. The property has been known as the Cornish Market for the past thirty years.

The Cornish Market is a single-story rectangular frame structure that stands at 613 Hill Street in the west side neighborhood of Salisbury, Wicomico County, Maryland. The store is located on the northwest corner of the intersection of Hill and First streets with the corner entrance facing south.

Built around 1910-20, the rectangular frame store is supported on a low masonry foundation, and the exterior is clad with horizontal weatherboards. The medium pitched gable roof is covered with asphalt shingles. Sheltering the southeast and southwest sides is a shed roofed porch supported on metal posts.

The main entrance, piercing the southeast corner, is a double-door opening filled with partially glazed doors. A large double window flanks the entrance bay to the west, and a rear entrance is located in the northeastern corner. A single flue brick stack rises through the gable end.

The interior is fitted with counters and shelves. A sheathing of narrow tongue and groove boards covers the walls.


