The Marion A. Humphreys house is one of the best detailed of the Colonial Revival frame dwellings to stand in the Camden Historic District. Dating to 1904, the two-and-a-half story, center hall house is dominated by a colossal columned Ionic portico, and the front entrance is enhanced by beautifully crafted leaded glass windows. The blockish frame structure is trimmed with bold Colonial Revival details such as the modillion block cornice that trims the edge of the roof and the Tuscan columned porch that wraps around three sides. The broad hip roof was formerly trimmed with a rooftop balustrade that served as a crowning architectural embellishment.

This expansive and elaborate frame house was erected for Marion A. Humphreys and his family in 1904. The construction date is confirmed in an article written for the Wicomico News on December 15, 1904, which recounted the brisk pace of improvements accomplished throughout the city during the year. The newspaper stated, "The magnificent residence erected by Postmaster M. A. Humphreys on Camden Avenue will do much to improve that section of Salisbury..." Marion A. Humphreys had purchased 7 acres in "Camden" with William S. Gordy, Sr. and Graham Gunby in January 1903 in an effort to speculate on the future popularity of this expanding neighborhood. In April 1904 of the following year, Gunby and Graham conveyed their interests in "Lot No. 3" to Marion A. Humphreys. Marion and his wife Caroline retained ownership of their Colonial Revival residence until June 1920 when they conveyed title to Jesse D. Price, who assumed responsibility for the

\$4,000 mortgage balance. During the years following the stock market failure Jesse D. and Sallie A. Price mortgaged their property and ultimately lost in a foreclosure. Long-term occupants during the mid twentieth century were Curtis W. and Mary Louise Long, whose family ownership stretched from 1938 to 1968.

The Marion A. Humphreys house is located at 722 Camden Avenue in the Camden Historic District of Salisbury, Wicomico County, Maryland. The two-and-a-half story, three-bay by three-bay faces east.

Erected in 1904, the two-and-a-half story, center hall/double-pile frame dwelling is supported on a raised brick foundation, and the exterior is clad with plain weatherboard siding. The truncated hip roof is sheathed with asphalt shingles. The crest of the roof was formerly trimmed with a balustrade.

The east (main) elevation is a symmetrical three-bay facade dominated by a colossal columned portico of the Ionic order. Tall fluted Ionic columns rise two full stories and support a pediment roof. The center entrance is fitted with leaded glass within the sidelights and transom, and the front door is partially glazed. The bays to each side are filled with eight-over-one sash windows hung with louvered shutters. Sheltering the first floor to each side of the portico is a single-story Tuscan columned porch. The second floor of the house is defined by an elaborate Palladian-style door and window opening in the center bay and flanking eight-over-one sash windows to each side. Fronting the tripartite door/window is a second floor balcony of paneled posts with ball finials. The center door is flanked by four-over-one sidelights. The base of the hip roof is enhanced with a bold modillion block cornice enriched further with a dentil row. The front edge of the portico pediment is trimmed in the same way. Piercing the center of the tympanum is a half-round lunette window. Rising through the center of the house are interior brick chimneys finished with corbelled caps.

The north side of the house is defined by an asymmetrical fenestration of eight-over-one and smaller sized windows. Marking the northeast corner under the Tuscan columned porch is a bay window featuring paired sash windows flanked by louvered shutters. The second floor is lighted by three eight-over-one sash windows, and the hip roof is defined by a pair of hip roofed dormers.

The south side of the main block is finished in a similar fashion with a portion of the first floor sheltered by an extension of the Tuscan columned porch. The first and second floor are lighted by eight-over-one or six-over-one sash windows flanked by louvered shutters. The base of the roof is trimmed with the modillion block cornice, and a pair of hip roofed dormers mark the south slope of the hip roof.

The interior was not seen.

The Marion A. Humphreys house is one of the best detailed Colonial Revival frame dwellings to stand in the Camden Historic District. Dating to 1904, the two-and-a-half story, center hall house is dominated by a Colossal columned Ionic portico, and the front entrance is enhanced with beautifully crafted leaded glass windows. The blockish frame structure is trimmed with bold Colonial Revival details such as the modillion block cornice that trims the edge of the roof and the Tuscan columned porch that wraps around three sides. The broad hip roof was formerly enhanced with a rooftop balustrade that served as a crowning architectural trim.

This expansive and elaborate frame house was erected for Marion A. Humphreys and his family in 1904. The construction date is confirmed in an article written for the *Wicomico News* on December 15, 1904 which recounted the brisk pace of improvements accomplished throughout the city during the year. The newspaper stated, "The magnificent residence erected by Postmaster M. A. Humphreys on Camden Avenue will do much to improve that section of Salisbury...."<sup>1</sup> Marion A. Humphreys had purchased 7 acres in "Camden" with William S. Gordy, Sr. and Graham Gunby in January 1903 in an effort to subdivide and sell lots along

this southern extremity of the city.<sup>2</sup> In April the following year Gunby and Graham conveyed their interests in "Lot No. 3" to Marion A. Humphreys.<sup>3</sup> Marion and his wife Caroline retained ownership of their Colonial Revival residence until June 1920 when they conveyed title to Jesse D. Price, who assumed responsibility for the \$4,000 mortgage balance.<sup>4</sup> During the years following the stock market failure Jesse D. and Sallie A. 
