The William H. Rounds house represents a standard side hall/double-pile house form commonly erected during the third quarter of the nineteenth century on town lots. The narrow two-bay street elevation contains the side entrance as well as an adjacent nine-over-six sash window, and the second floor is lighted by nine-over-six sash also. Highlighting the front entrance is a heavily molded four-panel front door, a common type of door used during the 1860s and 1870s. The double-pile frame dwelling has an overlay of early twentieth century design with a story-and-a-half addition to the south, and a gable roofed hood and neoclassical pilasters that frame the entrance.

Architectural features point to a third quarter of the nineteenth-century date of construction for this frame dwelling. For nearly fifty years, between 1872 and 1921, the house was held by Elizabeth E. Rounds or her husband William H. Rounds. Prior to 1872 the property was part of the land held by the trustees of the Methodist Protestant Church, who acquired the lot in July 1845. The deed of transfer conveys "Lot No. 5" of "Mill Grove and Sandy Plains" from Nathan Gordy of Worcester County to Augustus G. Grove, Henry Brewington, Stephen B. Collier, Samuel Kelly, George Calloway, Spicer Gordy, and Benjamin Maddux, "Trustees of the Methodist Protestant Church in Camden in the vicinity of Salisbury in Somerset County for \$100.

Prepare both a one paragraph summary and a comprehensive description of the resource and its various elements as it exists today.

The William H. Rounds house is located at 329 Camden Avenue in the Camden Historic District in Salisbury, Wicomico County, Maryland. The two-story, two-bay frame dwelling faces west with the gable roof oriented on a north/south axis.

Estimated to date around 1860, the two-story, two-bay main block is supported on a low brick foundation and the exterior is clad with asbestos shingles. The medium pitched gable roof is covered with asphalt shingles. Attached to the south gable end is a mid twentieth-century, story-and-a-half addition.

The west (main) facade of the nineteenth century house is a two-bay elevation with a side entrance and a flanking nine-over-six sash window framed by a plain surround. The heavily molded four-panel front door is enhanced with a gable roofed hood supported on scroll brackets. The doorway is flanked by narrow pilasters. The second floor is defined by a pair of nine-over-six sash windows. The windows are flanked by artificial shutters. Trimming the base of the roof is a boxed cornice enriched with mid nineteenth-century bed and crown moldings.

The north gable end is defined by a nine-over-six sash window in the northwest bay and smaller multi-pane window in the northeast bay. The second floor is lighted by a pair of nine-over-six sash windows, and the gable end is pierced by a single six-over-six sash window. Each of the window openings are flanked by vinyl shutters. The gable end is flush and trimmed with a molded bargeboard.

The south gable end of the main block is largely covered by a story-and-a-half, single-bay frame addition, which is lighted by a combination of six-over-six and multi-pane sash windows. A shed roofed dormer marks the west slope of the addition roof.

The interior was not seen.






