Located on the south side of Mount Hermon Road at the intersection with Airport Road, the Twilley House is a two-and one-half-story, two-bay, frame building with asbestos siding. This circa 1920 four-square plan house has an asphalt shingle hipped roof and front dormer with triple nine-over-one-sash window, nine-over-one- and twelve-over-one-sash windows, one interior brick chimney, and raised brick foundation and basement. The door is flanked by sidelights. The front porch has been enclosed and there is a one-story rear ell and two-story side ell. Attached to the house is a one-story building that was originally a detached general store.



**Resource Sketch Map**





