1889

Wholesale tobacco merchant Henry S. Todd erected this sizable Victorian brick house on Park Avenue in 1889, shortly after the purchase of the property from G. H. Toadvine. On June 8th, the *Salisbury Advertiser* announced that Todd had acquired the lot,

and will begin at once the erection of a new residence for himself. The building will be of brick, two stories high. The front building is to be 24 x 36 and the back building 14 x 14, with front and side porches. A. W. Lankford has the contract to do the brick-work, Mr. W. E. Wailes will do the woodwork.

The Victorian brick house was actually built in an ell shape with shorter two-story wings extending in several directions. Filling the interest in asymmetrical design in a tall, vertical format, the two-story brick walls rise to steeply pitched gable roofs that were trimmed originally with pointed finials in each gable, a feature that strengthened the sense of verticality. During the early to mid twentieth century the first floor interior was reworked with Colonial Revival and Craftsman style features.

Henry S. Todd conveyed title of the Park Avenue house and lot to his wife Agnes in 1893, and the property remained in her hands until her death. In 1941, her executors, Henry S. Todd, Jr. and F. Phelps Todd sold their parents Park Avenue property to William E. and Cleo Morgan, who in turn sold it three years later to Melvin C. and Mary Eleanor Horsey. The Horseys retained tenure in the property for nearly thirty years.

The Henry S. Todd house stands at 402 Park Avenue in the Newtown Historic District in Salisbury, Wicomico County, Maryland. The two-story, ell-shaped Victorian house faces east with the principal gable roof oriented on a north/south axis. The house is joined on the lot by a single-story, board-and-batten frame barn.

Erected in 1889, the two-story ell-shaped brick main block extends in each direction with gable roofed wings, and the front and south and north sides are largely covered by a single story neoclassical wraparound porch that includes a porte cochere on the north. The brick walls, laid in seven-course common bond, rise to steeply pitched gable roof covered with asphalt shingles. The edge of the roof has extended eaves with open soffits and decorated rafter ends.

The east (main) façade is an asymmetrical elevation with a recessed entrance flanked by a projecting gable roofed pavilion to the south and a long window to the north that reaches to the floor. The double front door features leaded panes and a leaded glass transom. The window openings are spanned by segmental arches executed in a double rowlock pattern. The wooden header to each window is embellished with an incised scroll decoration. The windows are fitted with multi-pane sash, and flanked by louvered shutters. Sheltering the first floor is a Tuscan columned, flat roofed porch that extends around the south corner of the main block as well as including a porte cochere on the north. The center bay over the main entrance has been changed from a window to a door so that access is provided to the flat roofed porch. The adjacent window openings, fitted with multi-paned sash, are flanked by louvered shutters. The projecting pavilion, as well as an adjacent gable over the north bay of the main block, are defined by gable ends sheathed with fishscale shingles. The gables are pierced by rectangular openings currently fitted with later window vents. The extended eave has bracket supports at the lower corners of the roof, and pendant drops in the peak. Wooden finials formerly rose from each peak.

The south side of the house is an asymmetrical façade with a projecting gable roofed wing that extends beyond the line of the wraparound porch. The first story opening on the wing has been altered with the installation of a tripartite window. The second floor retains its original window with a double rowlock segmental arch. The gable end is finished with fishscale shingles, extended eaves, open soffit, corner brackets, and a wooden pendant drop. The north gable end follows in the same format with consistent finishes.

Attached to the back of the house is a two-story, one-room plan brick wing, which has been extended on two sides. To the rear is a two-story porch dated by an inscription to 1912, and a two-story, shed roofed frame addition enclosing bathrooms is attached to the south side of the kitchen. A brick stack rises through the southwest corner of the main block.

The interior has been modified since its original construction in 1889. The first floor was reworked to a large degree during the 1940s. The staircase was rebuilt, wider door openings were installed between the hall and its adjacent rooms, and the mantels were redesign in a Craftsman style. The second floor retains some of its 1880s woodwork including four-panel doors topped by movable transoms. Several doors retain mahogany graining.

The board-and-batten barn stands behind the house and is a single story board and batten structure supported on a concrete slab. The barn has a gable front principal façade with doors and six-over-six sash windows piercing the wall surface. A medium pitched roof is covered with asphalt shingles.


