Defining the corner of Park Avenue and Chestnut Street is a distinctive two-and-a-half story cross-gabled frame dwelling that survives with its essential late nineteenth-century architectural character intact. Particularly noteworthy is the series of pointed finials and pendant drops that distinguish each gable. The main block as well as the service wing are embellished with extended eaves and decorated bargeboards typical of late Victorian domestic design in Salisbury. The house features as well one and two-story bay windows fitted with colored glass panes. The property is enhanced also by two surviving outbuildings.

For most of its history this house has been owned by Albert and Carrie Estelle Smith and their son Albert C. Smith; a tenure that stretched over one hundred years. In January 1890 the corner lot was sold by Gordon H. and Martha J. Toadvine to Carrie Estelle Smith for \$500 at a time when "Park Street" was being developed. Albert Smith is identified in the 1907 city directory as a "lumber merchant" and he and his wife, "Stella," are listed at their residence on Park Street. The house and lot remained in family hands until 1994.

The Albert Smith house is located at 300 Park Avenue on the northwest corner of Park Avenue and West Chestnut Street in the Newtown Historic District of Salisbury, Wicomico County, Maryland. The two-and-a-half story, three-bay, center hall plan late nineteenth-century frame dwelling is supported on a raised brick foundation with a partially excavated cellar, and the exterior is clad with a combination of asbestos shingles and decorative fishscale shingles. The steeply pitched cross gable roof is covered with asphalt shingles. Attached to the back of the main block is a two-and-a-half story service wing. Joining the house on the lot are two gable roofed outbuildings.

Dating around 1890, the two-and-a-half story, single-pile, main block has a symmetrical three-bay façade with a center entrance and flanking two-over-two sash windows. The front door is a replacement, but the entrance survives with a tripartite transom executed with cross-pattern muntins and ten-pane sidelights. The adjacent windows retain shutter pintels but the shutters have been removed. Sheltering the first story is a cross-gabled, hip roofed porch supported on fluted posts. The second story is lighted by three evenly spaced two-over-two sash windows, and piercing the cross gable is a pointed arch four-over-two sash window. The edge of the steeply pitched roof is trimmed with an extended eave, open soffits, and decorated bargeboards. Fixed in the peak of the cross gable is a turned wooden finial and pendant. The bargeboard is enhanced with round medallions. Piercing the roofline is a stove chimney on the south side of the center passage. A second stack rises between the north parlor and the rear service wing.

The south gable end of the main block is dominated by a two-story, cross-gabled pavilion. The pavilion has three principal sides pierced by multi-paned windows with colored glass perimeter panes. A band of fishscale shingles cover the wall area between the first and second floor windows. Hanging from the outer edges of the shed roof over the bay are fan-shaped brackets. Located above the two-story pavilion is a pointed arch four-over-two sash window that lights the attic of the main block. The edge of the roof is finished with an extended eave trimmed with decorated bargeboards and exposed rafter tails.

The north gable end is defined by single two-over-two sash windows on the first and second floors, and a pointed arch four-over-two sash window lights the attic. The edge of the roof is finished with an extended eave and decorated bargeboards.

Covering the west (rear) wall of the main block is a two-and-a-half story, three-bay by one room service wing, which is extended on the south side by a single-story cross-gabled shed roofed enclosed porch and on the north side a single-story bay windows. The rear wing is finished in the same manner as the front block with extended eaves, open soffits, and decorated bargeboards. Pointed arch windows pierce cross gables on the north and south roof slopes. Attached to the back of the service wing is a single story gable roofed cellar entry.

Standing southwest of the service wing is a single-story, rectangular frame privy covered by a steeply pitched gable roof finished like the house with extended eaves and open soffits. The exterior is covered with a combination of plain weatherboard siding and fishscale shingles.






Sanborn Insurance Map, 1904
