The Dr. W. Harrison Dashiell house is one of the most unusual and best preserved of the late nineteenth century dwellings that stand in the village of Quantico. Built around 1890, the two-and-a-half story house features double pavilions that flank the center entrance. Fixed between the pavilions are first and second floor porches framed by Victorian decoration. The center hall/single-pile plan house survives with much of its interior woodwork including a three-flight turned baluster stair and factory-made mantels and doors. Attached to the back of the house is a two-story service wing with a turned post porch its east side.

The Dr. W. Harrison Dashiell house stands on the south side of Cherry Walk Road in the village of Quantico, Wicomico County, Maryland. The house faces northwest with the principal gable roof oriented on a northeast/southwest axis.

Built in 1890, the northwest (main) elevation of the house is a symmetrical three-bay facade with a center entrance and flanking two-story, three-sided bay pavilions covered by gable front roofs. The front door, recessed within a turned post porch, is partially glazed. A second floor porch, covered by a shed roof, features a turned baluster handrail and spindle decoration under the eave. The sides of both bays windows are pierced by two-over-two sash windows on each floor, and each window is flanked by louvered shutters. Pointed arch windows pierce the gable end, and the drop pendants and sawnwork finish the bottom edge of the pavilion roofs. Rising through the center of the house is a pair of brick chimneys finished with corbelled caps.

The gable ends are alike with single two-over-two sash windows lighting the first and second floors, and pointed arch two-over-two sash window illuminate the attic. The eaves are extended and trimmed with plain bargeboards featuring decorated ends.

The southeast (rear) wall of the main block is largely covered by the two-story wing which has a turned post porch on the east side. Two-over-two sash windows light the first and second floors. Attached to the back of the two-story section is a single-story kitchen.

The interior of the house has remained largely intact since the late nineteenth century. Dominating the center hall is a turned baluster stair that rises in three flights to the second floor. The first and second floor rooms feature factory-made mantels with slender columns supporting a bracketed mantel shelf. The frieze of each mantel is incised with a floral decoration. Reused in the rear wing is a pair of two-panel Greek Revival doors. A secondary staircase rises in the back of the house.

Due to its high architectural integrity, this property is classified under Category A, which includes structures of historic significance that also exhibit many good architectural details representative of a period of architectural development and contribute uniquely and superlatively to the character and collective value of structures within the district.
