Royal Oak Methodist Church is a diminutive late nineteenth century frame structure that defines the intersection of Nanticoke and Royal Oak roads. Erected around the turn of the twentieth century, the gable-front frame church is trimmed with a modest degree of Victorian finish. The extended eaves have decorated rafter ends, and small brackets underpin the lower corners of the roof. The bargeboard has a delicate sawtooth decorative edge. Piercing the front wall is a single pointed arch door opening, and the sides of the church are marked by two pointed arch window openings.

Royal Oak Church is one of a handful of one-room religious buildings erected in western Wicomico County around the turn of the twentieth century.

Royal Oak Methodist Church stands on the northwest corner of the intersection of Nanticoke Road and Royal Oak Road with the modern address of 92030 Nanticoke Road, Wicomico County, Maryland. The single-story frame church faces southeast with the gable roof oriented on a northwest/southeast axis.

Built around 1900-10, the single-story frame church rests on a low concrete block foundation, and the exterior is clad with aluminum siding. The steeply pitched gable roof is covered with asphalt shingles. Attached to the back of the church is a metal mobile home.

The southeast (main) elevation is a gable front facade with a center double door entrance topped by a Gothic arched transom filled with opaque clear glass. The doors are replacements. A photograph taken by Orlando Wooten in 1977 indicates that a diamond shaped opening pierced the upper gable end, but it has since been covered with siding. The edge to the roof is finished with an extended eave, and a delicate saw-tooth bargeboard trims the eave. Fixed at the bottom corners of the roof are simple sawn brackets.

Each side elevation is two bays across and each bay is defined by a pointed arch window opening filled with opaque glass. The eaves of the roof are extended with decorated rafter ends exposed. Rising through the east side of the roof is a single flue brick chimney, which has been capped immediately above the roofline.

The rear wall is partially defined by a shorter single story, gable-roofed apse, which is obscured by later shed roofed additions to each side and the metal mobile home directly behind the church.

The interior was not seen.
