Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Eschenburg house at 102 South Main Street, Berlin, sits above the street on the west side. The hill front is embanked by a brick wall with cement top that returns at the north corner of the property. A flight of terra cotta steps interrupts the wall toward the south end. The steps, corners and end of returns are punctuated by brick piers.

The 1½-story dwelling is frame construction covered with stucco and has a gable roof with jerkinhead ends. The wide roof overhang is boxed with decorative braces on the gable sides and ends. Lower cross gables are centered in the front and rear facade, each with a 6/6 window flanked by slightly shorter 6/6 windows.

The principal facade (east) has five bays, the door being in the central bay. The entrance features side lights with twelve panes. The remaining bays are 9/1 windows. A small portico with a flat roof is centered under the cross gable at the entrance. It is distinguished by a pair of large square tapered columns and a low arch.

Extensions on the north and south ends, originally symmetrical, have been enclosed on the north and enlarged on the south. Each features the same deep overhang with braces. A band of unstuccoed brick marks the top of the foundation around the entire structure.

Prepare both a summary paragraph of significance and a general statement of history and support.

This dwelling was built in 1928 by the Safburg family, according to the current owner. The house is unique in style and combination of materials to Berlin and as such contributes to the range of early twentieth century houses in the historic district.

The brick wall, and "Burley Hill" set in terra cotta tile at the base of the steps predate the house. The wall also embanks the property on the south and since the steps are centered in the frontage of the combined properties, lends strong evidence to the local story ownership by the Ettinger family who planned to build a large house with stable and servants' quarters. The plans were altered by World War I and the property divided. The existence of a large frame dwelling at the rear of the Eschenburg property creates speculation that this was one of the Ettinger buildings and merits further study.
