The Adams house, tree-shaded on the front, is located on the east side of South Main Street near the end of the residential area. The house, unaccompanied by outbuildings, was built in the 1920's.

This frame 1½-story bungalow is 3 bays wide by 4 bays deep with a gable roof. A shed-roofed verandah extends across the front facade with a large dormer centered in the front gable roof. The house has two chimneys with arched caps; one, partially exposed, on the south front slope of the roof and the other, an interior chimney on the north rearslope. The structure sits atop an ashlar-faced block foundation raised to accommodate basement windows on the north and south sides. 1/1 windows are used throughout, with aluminum siding and shutters.

The front or west facade is symmetrical with the entrance in the center bay. The flanking windows on each side are triple 1/1, the center window being wider than those on each side. The dormer also contains 3 smaller 1/1 windows and is most notable for its deep roof overhang, accentuated by simple triangular knee braces, one in the peak of its gable roof and one at each end. (These knee braces are also used in the roof overhang of the gable ends of the north and south facade.) The verandah has 4 block piers extending from ground level to window level surmounted by square tapered wood columns. The front steps repeat the pier construction.

On the rear facade is a gable-roofed basement entrance. An enclosed shed-roofed porch sits atop ashlar-block piers.


