The Snow Hill Municipal building is a distinctive early twentieth-century town government structure that originally combined the local fire department and town offices in the same space. The first floor was initially erected to include an entrance for fire equipment, but the front was refitted with a more classical doorway after the fire department relocated. The building exterior has otherwise remained essentially unchanged with a well preserved metal cornice that trims three sides of the structure.

Construction of the municipal building in 1908 is recorded by the date plaque above the entrance as well as in an entry of the Democratic Messenger of July 27, 1908, which offered local contractors the opportunity to bid on the project. The building proposal read,

The Mayor and Council of Snow Hill, Maryland will now receive until noon, August 10, 1908, sealed proposals for the erection of a two-story brick building on the corner of Bank and Green Streets, in Snow Hill. Plans and specifications for this building may be seen by application to the Secretary.

The Snow Hill Municipal building stands on the southwest corner of Green and Bank streets in the center of Snow Hill, Worcester County, Maryland. The two-story four-bay by four-bay brick building faces northeast. Despite the four-bay by four-bay elevations, the building is not exactly square with the rear wall shorter than the front wall.

Built in 1908, the two-story stretcher bond brick building is supported by a poured concrete foundation, and the flat roof is hidden by a bold metal cornice that trims three sides of the structure. The Bank Street (main) elevation is a symmetrical three-bay facade with a center entrance and flanking single-pane sash windows. A classical surround of pilasters and a pediment frame the front door which is bordered by six-pane sidelights and a multi-pane transom. This classical entrance was inserted in place of the round arched, double garage doors that allowed the entrance of the early hook and ladder fire equipment. The adjacent single-pane sash windows, originally doors topped by round arches, are surmounted by jack arches. Marking the wall between floors is a name plaque that bears the imbossed dates 1894 and 1908 to either side of "MUNICIPAL BUILDING." The second floor is lighted by four single-pane sash windows and the two center windows are paired together. Between the center two windows and the outer windows are inset brick rectangular panels. The windows are fitted with concrete sills and jack arches. Stretching across the top of the building is a heavy metal cornice with an array of molded patterns. Just below the crown molding is a egg-and-dart row.

The south wall is marked by three single-pane sash windows on the first floor and four windows light the second floor. As with the front of the building the center two windows are paired closer together. The north wall, on the other hand, is a three-bay elevation with a center entrance and flanking single-pane sash windows. Three identical windows light the second floor. The west (rear) is an asymmetrical two-bay facade with a rear door and single-pane sash windows. The metal cornice does not stretch across the back of the building.

The interior has been reworked to some degree as town offices, but some early twentieth-century features including the stair survive.





