The Sno-Mar gift shop occupies a two-story stretcher bond brick commercial building that was erected shortly after the disastrous 1893 Snow Hill fire that devastated a large part of the central business district. With its slightly higher elevation and arched second floor windows, the two-story brick storefront contrasts with the contemporary adjacent buildings. Originally, the first floor included a separate two-bay office that was for many years occupied by Dr. John S. Aydelotte. More recently the larger, consolidated floor space was the location of the local Ben Franklin department store.

The Sno-Mar gift shop stands at 112 Green Street in the central business district of Snow Hill, Worcester County, Maryland. The two-story, four-bay brick building faces southeast.

Built around 1894, the two-story, stretcher bond commercial building is marked by a reworked first floor front of large glass display windows to each side of a recessed entrance. The first floor was probably reworked during the 1960s or 1970s. Marking the second floor level are four six-over-six sash windows highlighted by marble sills and round brick arches. The three-course rollock arches span are arched fanlight above each window. Topping the stretcher bond facade is a decorative corbelled brick band below a metal cornice.

The sides of the building are covered by adjacent commercial structures, and the first floor interior has been reworked. The second floor was not seen.



The Sno-Mar gift shop building was erected shortly after the 1893 Snow Hill fire for the 1895 Sanborn Insurance map designates a building at this location. The former configuration of the first floor included a smaller shop front and an adjacent office. Large plate glass display windows flanked a recessed entrance, while the office was marked by arched door and window openings. For many years the office was occupied by Dr. John S. Aydelotte. Within more recent times the consolidated space was the location of the Ben Franklin department store chain.

The two-story, four-bay brick commercial building stands in a row of relatively unaltered late nineteenth-century store buildings and contributes to the variety of consistent period architectural features that distinguish Green Street.
