The architectural features and the land records research for this property indicate this unusual two-and-a-half story frame dwelling was built during the later years of the nineteenth century, by Ella King Wilson Hargis (1856-1935) and Marian Toadvine Hargis (1858-1935) who owned this corner property at the time. The large ell-shaped dwelling is distinctive for the combination of patterned slate mansard and gable roofs as well as the projecting bay window and Tuscan columned porches.

Ella K. Hargis is recorded in Worcester County land records as purchasing this lot from George W. and Ellen Bishop for \$650, "where Jonathan Hurlock now resides." With this reference to some sort of dwelling along with the relatively large transfer price, the corner lot was evidently improved in June 1887 when Ella Hargis acquired title, but it is uncertain whether the original improvement is incorporated in the existing house. Hargis family ownership continued after Ella's and her husband, Marian's deaths in 1935. The property did not leave family hands until Samuel E. Shockley purchased the house and lot in the fall of 1946.

The Hargis-Shockley house is located on the southeast corner of the intersection of Church and West Federal streets in the center of Snow Hill, Worcester County, Maryland. The two-and-a-half story center hall frame house faces southwest with the principal gable roof oriented on a northwest/southeast axis.

Built around 1880, this two-and-a-half story, ell-shaped frame house rests on a low common bond brick foundation, and the house is uniformly sheathed with aluminum siding. Covering the house is a combination of gable and mansard roofs covered with patterned slate. Extending to the rear is a two-and-a-half story ell wing.

The southwest (main) elevation is an asymmetrical facade with a centrally located entrance and flanking single-pane sash windows. The double-door entrance and the flanking windows are sheltered by a Tuscan columned porch built into the front corner of the uneven facade. The porch stretches around to the south gable end. The second floor is lighted by three single-pane sash windows each of which are trimmed with decorated lintel moldings. Centered on the roof is a cross gable fitted with a small two-over-two sash window. Dominating the northwest corner of the ell-shaped dwelling is the mansard roofed section highlighted by a hooded first floor window on the south side and a bay window on the north side. The eaves to both projecting roofs are trimmed with brackets. The second floor is lighted by single-pane sash windows. Highlighting the bell-curved mansard roof are gabled two-over-two sash dormers. An interior brick stack rises through the center of the house between the mansard and gable roofed sections.

The northwest side contains a prominent entrance as well with a Tuscan columned portico sheltering a glazed door opening. Single-pane sash windows light the first and second floors. An interior brick chimney rises through the middle to the rear wing.

The interior was not seen.


