The Mary B. Vincent house is a two-and-a-half story gable front frame dwelling that follows a side hall/double-pile floor plan. Built around 1860, the house displays a combination of mid nineteenth century finishes including an original stair, four-panel doors, and four-over-four sash windows. The roof to the house was rebuilt during the late nineteenth century and is trimmed with modest peak decoration. The shorter two-story wing appears to date to the same period and survives with horizontal board wainscoting. The location of a former back stair is evident in the flooring of a back bedroom.

Construction of this two-and-a-half story frame dwelling is estimated to date to the mid nineteenth century during the ownership of Mary B. Vincent, which stretched from her purchase of Lots 56 and 57 in 1857 to 1866 when she sold the house. The Civil War era finishes of the house agree with the date period. Shortly after her sale of the house, the property changed hands three times within eight years until Edward D. Marshall, a town physician, purchased the property. One of the longest occupants of the Church Street house was George W. Coulbourn, who owned the property between 1902 and his death in the early 1920s.

Historically known as the Mary B. Vincent house and called more commonly the George W. Coulbourn house, this two-and-a-half story gable front frame dwelling stands 105 North Church Street in the center of Snow Hill, Worcester County, Maryland. The house faces southwest with the principal gable roof oriented on a northeast/southwest axis.

Built around 1860, this two-and-a-half story side hall/double-pile frame house is supported by a low brick foundation, and it is sheathed with a layer of aluminum siding. The steeply pitched gable roof is covered with a layer of asphalt shingles. Attached to the back of the house is a shorter two-story wing.

The southwest (main) elevation is an asymmetrical two-bay facade with a side entrance and flanking paired four-over-four sash windows. The heavily molded four-panel front door is flanked by two-light sidelights and topped by a three-light transom. The front door and the adjacent window opening is framed by louvered shutters. The second floor is pierced by two evenly spaced paired four-over-four sash windows also hung with louvered shutters. Illuminating the attic is a paired four-over-four sash window opening retaining louvered shutters as well. Trimmed the corners of the house are wide pilasters, and the eave to the roof is extended with returns at the base. Fixed in the upper gable is a small eave decoration. A brick chimney protrudes through the roof and is finished with a corbelled cap.

The northwest side of the house is marked by a projecting gable entry on the first floor flanked by a paired four-over-four sash window. The second floor is lighted by evenly spaced four-over-four sash windows that retain louvered shutters. Centered on the north roof slope is a large cross gable that is enhanced with the same eave decoration and pierced by a single four-over-four sash window. The south side, finished with similar features, is extended with a single-story bay window.

The shorter two-story rear wing is lighted by six-over-six sash windows, and a screened in porch is attached to the southeast side. Rising on the northeast gable end is an exterior brick stack. The brick chimney formerly rose between rooms when another room extended farther back from the current rear wing. Due to the delapidated condition of the back room it was torn away when the house was remodeled.

The interiors of the house retain mid nineteenth century woodwork common to the 1860s. A heavily turned Civil War era newel post and turned balusters support an oval profile handrail with the main stair. Surviving in the rear wing, which appears to be contemporary or perhaps slightly older, are sections of horizontal board wainscoting and a patched floor where a old stair was formerly located. The roof to both sections was rebuilt during the late nineteenth century.






