Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*
 This rural structure, historically "Tarr's Grocery," is located on the south side of George Island Landing Road, where it intersects with Greenbackville Road, (east of Stockton) in Worcester County, Maryland. The principal dwelling dates to 1910.

The two story frame structure has recently been renovated for residential purposes. The modest rectangular building is two bays along the front façade, with sides at least twice as long as that width. Openings are arranged symmetrically around both floor levels. The single, shallow gable roof form has been refinished in a corrugated metal sheathing. It appears the building has been lifted and new brick foundation piers recently added. The porch roof may be original but other elements of the porch construction have been modified dramatically. The building was resided some time ago with asbestos shingles. Most of the original windows have been replaced with aluminum clad, one over one double hung sash windows (with storms). The two front windows flanking the main entrance on the first floor, seem to be intact. They are wood, two over two, double hung sash. The wood door is not original.

The building is not representative of a unique or significant architectural style. It is not associated with significant individuals in history. Additionally, the structure has been altered significantly and lacks an integrity of materials, design and workmanship necessary for individual listing in the National Register.



Tarr's Grocery is a two-story, three-bay frame store that stands on the southeast corner of the intersection of George Island Landing Road and Greenbackville Road east of Stockton in the small community of Portersville, Worcester County, Maryland. The two-story frame structure faces north with the gable roof oriented on north/south axis.

Built around 1910, the asbestos shingled frame store is supported by a brick pier foundation covered with metal sheathing in the style of rusticated concrete block. The medium pitched roof is covered with tin. Attached to the back of the main building is a single-story wing clad with asphalt shingles.

The north (main) elevation is a three-bay facade with a center double-door entrance and flanking two-over-two sash windows. The first floor is sheltered by a shed roof, chamfered post porch. Lighting the second floor are two two-over-two sash windows. The eave to the roof is slightly extended and the rafter ends are exposed.

The west side elevation facing Greenbackville Road is marked by a double-door side entrance in the southernmost bay, and a pair of two-over-two sash windows light the second floor. The east side is treated in a similar manner.

Attached to the south gable end is a single story, two-bay wing that partially covers the second floor window of the main building. A single-flue brick stack rises against the gable end. The wing is lighted by six-over-six sash windows.

The first floor interior of the store retains counters, shelving, and an enclosed stair in the southwest corner.


