The Holloway House is located on a roughly one-acre lot on the southwest corner of Church Street and the former Worcester Railroad in the village of Showell, Worcester County, MD. The property, which consists of a single dwelling, is not considered eligible for individual listing on the National Register of Historic Places nor is it located within a National Register-eligible historic district.

The Holloway House is a 2-1/2-story, three-bay frame house with a two-story rear ell. The house is covered with a gable roof with a central projecting front gable and two interior chimneys with corbelled caps. The house has been altered by the addition of a double-story front porch (original single-story) and several additions to the rear ell. In its overall form and massing, the building is a typical example of the late 19th-century domestic architecture of the region and does not qualify for listing under Criterion C. The property is not known to have any associations with persons or events significant to our past and is thus not eligible for listing under Criteria A or B.

CONTRIBUTING RESOURCE COUNT: 1

Located on a roughly one acre lot on the southeast corner of Church Street's intersection with the former Worcester Railroad in the village of Showell, Worcester County, Maryland, the Holloway House consists of two-and-one-half story frame dwelling with a cross-gable dormer on its main, western elevation facing the railroad tracks. A two-story shed-roof porch shades the west elevation. Although partially enclosed, similar two-story porches also occupy both the north and south sides of the rear ell. A one story porch also protects the east gable end. Two interior, corbeled-brick chimney piles penetrate the main elevation's ridge while one brick chimney rises from the ell's ridge. Wooden shingles protect the house's exterior. Rusticated pressed-metal obscures the original foundation composition. Asphalt shingles sheathe the roofs.

The dwelling possesses three symmetrical bays across its west elevation. Two-over-two wooden sash flank the first story's central doorway composed of two vertical panels with a large upper light and a one-light transom. A nearly identical arrangement appears on the second story. The elevation's gable dormer exhibits a segmental-arched, two-over-two window in its peak. The east elevation totals five bays deep on the first story: one in the Tee's gable end and four deep along the rear wing.



Page 8.1; Significance

Related to the settlement of the village of Showell following construction of the Worcester Railroad during the 1870s, the Holloway House helps document settlement patterns as well as architecture in Worcester County in the late nineteenth century.

Prior to construction of the railroad, the Showell crossroads consisted of a few dwellings and a store/tavern located further east of the Holloway House along both sides of the Worcester Highway (modern US Route 113). A major north-south transportation network throughout the nineteenth century, the Worcester Highway provided an important route for traffic traversing the county prior to the railroad. The railroad, however, spurred new development west of the village at the intersection of Pitts Road with the rail line. Built immediately adjacent to the new railroad line with its main, western elevation facing the railroad, the Holloway House clearly relates to the increased settlement of Showell following construction of the railroad. An 1877 atlas map of West Berlin District illustrates the Holloway House. By the early 1890s, Showell contained 50 residents (Touart 1994:292-93).

The Holloway House also reflects the subdued characteristics of Gothic Revival architecture popular in the county during the late nineteenth century. A cross-gable Tee-plan, the Holloway House displays an arched-head gable peak window. These motifs are found on Gothic Revival dwellings throughout the county (Touart 1994:155).

Possessing good integrity of location, design, setting, materials and feeling, the Holloway House is recommended for inclusion on the Maryland Inventory of Historic Properties under Criterion A, associations with broad patterns of history, and Criterion C, embodiment of the distinctive characteristics of an architectural style.



 Showell, Worcester County, MD; Selbyville, DE-MD Quad Map


