The L. Coffin Farm consists of a detached, single-family dwelling and seven outbuildings. The property is located on the north side of Sinepuxent Road, in the community of Trappe, approximately 1.5 miles east of US 113. The two-story, two-bay dwelling, likely constructed in the third quarter of the nineteenth century, features a symmetrical south-facing entrance facade. The frame structure is covered with clapboard siding and exhibits a side-gabled roof clad with composition asphalt shingles.

The facade is characterized by a one-story, full-width, hip-roofed porch that has been screened. Turned support posts are visible behind the screening. A large, two-story, gabled wing extends from the rear (north) side of the house with a one-story shed addition on its east side, filling the angle created by the main block and the wing. On the west side of the wing is a small, one-story, hip-roofed bay. The windows feature two-over-two, double-hung wood sash in simple board surrounds. Entrance to the house is made via a single-leaf door in the west bay of the porch and another single-leaf door in the rear shed addition. A brick interior end chimney protrudes from the east end of the main block roof ridge, while a modern concrete block chimney is situated on the west exterior of the rear wing. The house also features corner boards and a plain fascia board beneath the simply molded cornice.

East/northeast of the dwelling is a large, three-level, frame barn in dilapidated condition. It exhibits weatherboard siding, various hinged and sliding board doors, and the remnants of a shingle roof. Directly south of the barn are two small outbuildings, a modern frame doghouse/pen and a frame corn crib with horizontal slat walls and the remnants of a shingle roof. Due east of these outbuildings are two sheds, each with vertical board walls and corrugated metal roofs. On the west side of the dwelling is a frame chicken house, with vertical board walls and the remnants of a shingle roof. Except for the modern doghouse/pen, the outbuildings appear to date to the early twentieth century, although the barn may be earlier. A gravel drive provides access to and from Sinepuxent Road, and the property features a small yard with a prominent magnolia in the front, a number of large trees to the rear of the house, a garden to the east of the drive, and open cropland to the north, east, and west.

Alterations to the dwelling include the screening of the front porch, the rear additions, and the exterior concrete block chimney. The outbuildings appear to have retained their historic design and materials, although the barn is in poor condition and the roofs of the corn crib and chicken house are failing.

The L. Coffin Farm is a good example of a vernacular farmstead that dates from the middle to later nineteenth century. Although the outbuildings are not contemporaneous with the dwelling, as a unit the structures and the surrounding cropland illustrate an intact farmstead. The farm is associated with a period in Worcester County agriculture when crops such as corn, oats, potatoes, hay, and flax were being produced both for subsistence and for sale outside the county. The community of Trappe, which grew up around the mills on Trappe Creek, was at this time almost fully eclipsed by nearby Berlin, which had been growing steadily since the early decades of the nineteenth century (Touart 1994:71, 79).

The farmhouse was likely constructed in the third quarter of the nineteenth century, based on physical inspection. Research of deed records has proven inconclusive, and the name "L. Coffin," as indicated on the 1877 Lake, Griffing, and Stevenson atlas, does not appear in the records. However, the location on the atlas is consistent with the location of the farmstead. Using the periods from the Maryland Comprehensive Historic Preservation Plan Data, this would place the farmstead in the Agricultural-Industrial Transition (A.D. 1815-1870). The current legal tax parcel containing the farmstead encompasses 39.05 acres.

The L. Coffin Farm is recommended ineligible for inclusion in the National Register of Historic Places in accordance with the criteria of eligibility in 36 CFR 60.4. Its integrity of design, materials, workmanship, and feeling has been compromised due to alterations. It has no known associations with significant historical events (Criterion A) or persons (Criterion B), it is not significant for its architectural style or design characteristics (Criterion C), and further research of it would not appear to yield information important in prehistory or history (Criterion D).






TAX MAP




