**Approval of Minutes**

Richard Longstreth moved to approve the February 28, 2023 meeting minutes. Peter Pearre seconded. No discussion. All in favor.

Appalachian Trail National Scenic Trail Maryland Segment, F-4-157 and WA-IV-278 (Federal Nomination)

Criteria Considered: A

Criteria Recommended: A

The discussion included the request for all photographs of structures to be included, the suggestion to add Criterion C with respect to the CCC buildings, and to include the narrative on the engineering significance of the Bollman Truss Bridge. NPS will follow up with the consultant for additional photographs and will consider including Criterion C. Following the discussion, Damie Stillman moved to recommend the nomination, Richard Longstreth seconded, and all voted in favor.

The Women's Suffrage Movement in Maryland, Multiple Property Submission

Criteria Considered: A, B

The discussion included recommendations to specify site locations and clarify what buildings are extant. A question arose regarding if suffrage march routes could be considered a property type, which brought up a discussion on integrity and the challenge on supporting specific route boundaries. Following the discussion, Nancy Schamu moved to recommend the nomination, Damie Stillman seconded, and all voted in favor.

BALTIMORE CITY

Edith Houghton Hooker House (Upland), B-5339

Criteria Considered: B

Criteria Recommended: B, C

The discussion included an interest in the relationship between the Hookers and the architect, Edward L. Palmer, and a recommendation to include Criteria C, with additional research in respect to whether Edith Houghton Hooker was involved with the design of the house as a gathering place and the inclusion of potentially extant floorplans. Following the discussion, Nancy Schamu moved to recommend the nomination, under the condition that a revised document be emailed to the GCC, on which they will vote by email; this was seconded by Peter Pearre, and all voted in favor.
